We, the Anderson Cavaliers, have implemented the following Parent Code of Conduct for the important message it holds about the proper role of parents in supporting their child in sports. Parents should read, understand and sign this form prior to their child participating in our league.

Any parent guilty of improper conduct at any game or practice will be asked to leave the sports facility and be suspended for the next game or practice. The Anderson Cavaliers have adopted a ZERO TOLERANCE policy and the below-described behavior will be demanded.\*

## *Preamble*

The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles:

- Trustworthiness
- Respect
- Responsibility
- Positivity
- Coachability
- Self-Control

The highest potential of sports is achieved when competition reflects these "six pillars of character."

## *I therefore agree:*

1. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
2. I will learn the rules of the game and the policies of the league.
3. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.
4. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, players, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.

5. I will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
6. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
7. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex, or ability.
8. I will respect the officials and their authority during the games. I will never question, discuss, or confront coaches at the game field. I will wait at least 24 hours and schedule a time to speak with coaches at an agreed upon time and place.
9. I will demand a sports environment for my child that is free from drugs, tobacco, and alcohol and I will refrain from using their use at all sporting events.
10. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.
